Collection of Attendance Dues \$2720.00 per annum and Proprietors Special Character Donation \$360.00 per annum:

You will have noticed that both the attendance dues and special character donation are now collected solely by our Proprietors. There are several ways you can pay, and they have communicated this to all parents.

Each year as a school we overwhelmingly appreciate parents paying the **Proprietor Special Character Donation** (**PSCD**). <u>The full amount of the Special Character Donation is passed onto the school by the Proprietor.</u> When our Board Finance Committee (parent trustees) meet, they are always anxious to know if parents have been able to contribute this donation because it is a serious deal breaker for managing our funds! We seek to steward these funds to enable us to provide over and above as a Christian school. Although the government approves us as an integrated school, they have no idea of what it costs to integrate our Christian faith across all aspects of school operation chiefly a 'Christian world-view saturation' in our learning spaces.</u> <u>Thank you, parents, for contributing this donation each year.</u>

The Proprietors Special Character Donation qualifies for a donation tax credit equal to $1/3^{rd}$ of the amount given. A receipt will be issued in April each year.
